#### **VARIATION ORDER 2017**

#### WHEREAS:-

- In exercise of the powers conferred by Section 20 of the Education Act 2002, and the School Governance (Constitution) (England) Regulations 2012 as amended by the School Governance (Constitution and Federations) (England) (Amendment) Regulations 2014 the County Council of Northumberland, being the Local Authority for the County of Northumberland, hereby make the following Order:-
- 2. In exercise of the powers conferred by Section 20 of the Education Act 2002 and The School Governance (Constitution) (England) Regulations 2012, as amended by The School Governance (Constitution and Federations) (England) (Amendment) Regulations 2014, The School Governance (Constitution and Federations) (England) (Amendment) Regulations 2016 and The School Governance (Constitution and Federations) (England) (Amendment) Regulations 2017, (hereinafter called "the Regulations"), the Governing Body reviewed the Instrument of Government and decided at its meeting on 14<sup>th</sup> September 2016 that it should be varied as set out in the Schedule to this Order.
- 3. The County Council are content with the proposed variation and have agreed to amend the Instrument accordingly.

In exercise of the powers conferred by the Regulations, the County Council hereby make the following Order:-

- 1. This Order may be cited as The Federation of Ashington Learning Partnership (Instrument of Government) Variation Order 2017.
- 2. The Instrument of Government shall be varied as set out in the Schedule to this Order.
- 3. This Order shall take effect on 15<sup>th</sup> September 2016.

### **SCHEDULE**

The Schedule to the Instrument of Government shall be varied as follows:-

- 1. In paragraph 4, for the category of governor "co-opted governors", delete the number "4" and replace with the number "6".
- 2. In paragraph 5, for the "total number of governors", delete the number "11" and replace with the number "13".

In exercise of the powers conferred by Section 20 and 24 of the Education Act 2002, The School Governance (Constitution) (England) Regulations 2012 and The School Governance (Federations) (England) Regulations 2012, as amended by the School Governance (Constitution and Federations) (England) (Amendment) Regulations 2014 and the School Governance (Constitution and Federations) (England) (Amendment) Regulations 2016, the County Council of Northumberland, being the Local Authority for the County of Northumberland, hereby make the following Order:-

- This Order may be cited as the Ashington Learning Partnership (Instrument of Government) Order 2016.
- 2. The Instrument of Government for the Ashington Learning Partnership shall be set out in the Schedule hereto.
- 3. The said Instrument of Government shall come into effect on 11th April 2016.
- 4. Any Order making the previous Instrument of Government is hereby revoked with effect from 11<sup>th</sup> April 2016.
